E-Newsletter: *Sir, tell us how EAMC generated, its scope, aims and objectives.*

Ing. Monda: The idea of Engineering Associations of Mediterranean Countries (EAMC) was born when I realized that almost all the efforts Consiglio Nazionale degli Ingegneri (CNI) made to the benefit of engineers were oriented to Europe. I thought that Italy has a privileged situation towards the Southern Mediterranean as it is a sort of bridge from Europe and Africa. Little by little this idea grew in me and I thought that a first step towards relationships among Northern and Southern shores of the Mediterranean could be the organization of a First Conference of Mediterranean Engineers. EAMC was born in my head. As CNI, and I personally, think that Engineers and their professional Associa-

tions must play an important role in sharing and transferring knowledge and technologies in increasingly technocultures and engineered societies, EAMC could become a net of Associations willing to cooperate to achieve this goal.

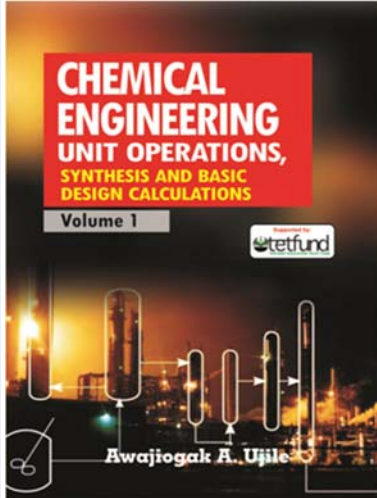
E-Newsletter: *What are the perspectives on the EAMC extension and future collaboration with other Engineering entities.*

Ing. Monda: A little time ago, I contacted my dear friend and colleague Giandomenico Massari about WECSI 2014 in Nigeria to present a paper in a session. Marwan Abdelhamid, President of WFEO, suggested to me to present EAMC too. After taking all agreements with the Nigerian Society of Engineers and Giandomenico, a distinguished representative of CNI, my dear colleague Prof. Enzo Siviero went to Abuja to illustrate EAMC and other initiatives. First stages of each collaboration are trust and mutual understanding. Our approach with FAOE should be the extension of a survey on training and professional regulations of each country of the area concerned. Then we will prepare a Draft Statement of Intent, which, once approved by the interested Parties, will be signed on a special occasion.
