INTERVIEW WITH PABOD BREWERIES MANAGEMENT ON THE SUSTAINABILITY OF PROCESS AND PRODUCTION.

E-Newsletter: We want to know about your profile and experience which has brought you into the management of PABOD Breweries Ltd.

GM: My name is Franz. Donef Brume, from Germany and a Brewer by profession. I studied Food Technology in Breweries. My first job as food technologist was with Coca Cola in Germany, later I got a job in Namibia, South Africa. I also got a fishing job in Namibia, I was there for twelve or thirteen years, then I decided to go back to Germany, there I also got a good offer with a big company though I was not happy with the job. Finally I got an offer in Africa, Nigeria with PABOD Breweries which I accepted.

E-Newsletter: What is your plan to sustain PABOD in terms of choice and source of raw materials, project financing/planning, technical capability etc?

GM: Thank you. At this moment our technical body is very very good. It is of high standard. We can make now easily up to 250,000 hectolitres per year. Initially, our sale was at low level but we are growing on a daily basis from a low level to medium and very soon perhaps before the end of the year we expect to achieve our target. Within a short time we will be in a position to be financially independent. Secondly we must have people here; we need technical people, financial people, so that what happened in 1996 when this company got stalled will not repeat itself. When we need spare parts, we must have it immediately and instal them as the need arises. That means we must see that Pabod Brewery's operation is high technically. For that I have to get human resources in all disciplines. For us we are on ground already with our people working.

E-Newsletter: What about local input? How far have you gone with engaging local engineers, technologists etc?

GM: It is actually a very good question, yes for sure we have done that. It is part of our policies, we must first see that we get local suppliers for certain products and local engineering companies to do the work. Fortunately here in Port Harcourt, there are competent companies that we have engaged. For example tomorrow, a company based in Port Harcourt will start the routine maintenance of our generator. It's a very reliable company. They are also working for Coca Cola, since Coca Cola is happy with them I am sure they are good. We are also trying to build up good relationships with Nigerian based companies especially within Port Harcourt, one after the other.

E-Newsletter: What is your relationship with your host community, Ogoni? What is your future plan for them?

GM: We've not done anything yet but in the nearest future we will open a social budget. Our aim is that we work together with the community but I need ideas, influence from workers as you may know we have Senior Workers Association and Junior Workers Union, unfortunately, I have not had meeting with them but I want to have them all together here at this table, so they can tell us their needs, what they want and their expectations. At the moment we have other problems but definitely we will do something. Absolutely, each company has social responsibility and we are not exempted.

E-Newsletter: Must companies get stalled as a result of poor communication between the Board of Directors and the company. How often do you brief your directors and shareholder on the progress development of your operation to create the continuous existence of this company?

GM: Yes, we will have few meetings per year with the Board of Directors and I being on the technical side, which may be an edge for the company, I will inform them on what we have to do, and what must be done and I can convince them that we need this and this amount for this and that maintenance. On the technical side, we are already at a good level, that's very important. Everybody is looking for it. But I am planning on long term. I am not planning for one year because if you are planning for short term, you don't put any money in the entire maintenance because that is the big part of your budget but we are planning for a longer term and we require maintenance from the beginning.

E-Newsletter: In your planning, do you have in mind to integrate recent engineering software to track progress development of your product in system like quality control, performance, reliability and efficiency?

GM: Yes, we have for Accounting, we have special software already for production. We till make do with Excel for some work. But when we develop further, I am sure we'll employ more software.

E-Newsletter: Thank you, from the facility tour of your operation, we have known that some of the operation is on continuous process and continuous processes will require certain softwares to enhance high productivity. So have it at the back of your mind to integrate certain process simulation software like Hysis and the like. It will help. You can consult Nigerian Society of Engineers. What is your future plan towards expanding the scope of this company? For now you have only two products, Grand Lager and Grand Malt.

GM: Thank you for asking this question. We have plans but we can't say when we'll start with it but definitely, we plan to start with bottling water either within one year or within the next three years, we don't know yet. Secondly, we want to produce the Can Brand Lager and Can Grand Malt and this will take time.

E-Newsletter: Thank you very much for giving us audience. We are Nigerian Society of Engineers and we are willing to help professionally in all engineering fields related to your production process because we don't want this company to experience what happened years ago. Once again thank you.

GM: Thank you very much. I guarantee you that we'll do all we can so that this company will not close down again.
